3) Vision Statement

"Our Vision for Bridgwater is a town Re-energised, ensuring the town is better positioned to benefit from existing and future investment in clean energy and clean sustainable growth. A town recognised as a place of education, enterprise, and innovation. A town that is socially conscious, culturally rich and colourful with a strong sense of civic pride and community".

The original Vision Statement (as seen in the statement above), has been edited in order to be more specific to Bridgwater. It was agreed to finalise the detailed wording in discussion with the Chair. New version can be seen below:

> "Our vision for Bridgwater is a town RE-ENERGISED, drawing maximum socioeconomic benefit from existing and future investment in clean energy and inclusive growth; in particular from the proximity of catalytic projects such as Hinkley Point C and the 600 acres of Gravity – a Smart Campus. Bridgwater Re-energised will be a town recognised as a place of education, enterprise and innovation. A town that is socially conscious and culturally rich; maximising its unique tapestry of cultural events, spearheaded by its awardwinning illuminated Carnival".


Comments from the board:

- Towns Hub annual review of progress with the board.



Comments from the board:


- Sub-group responsibilities contain the following:
